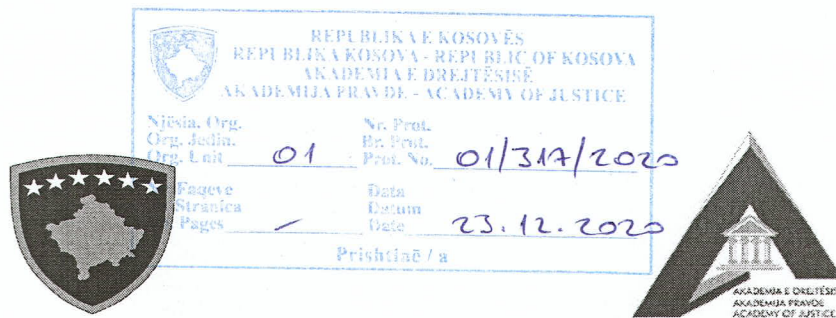
DECISION

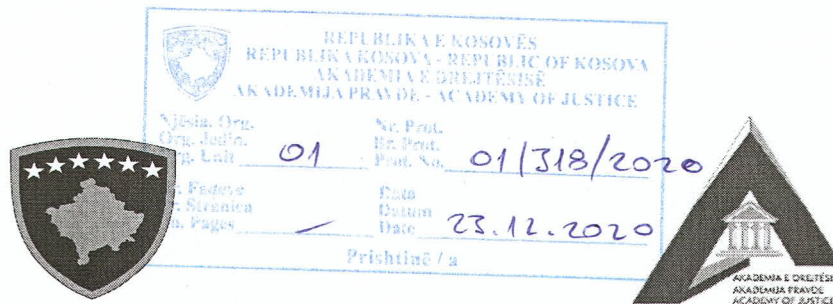
