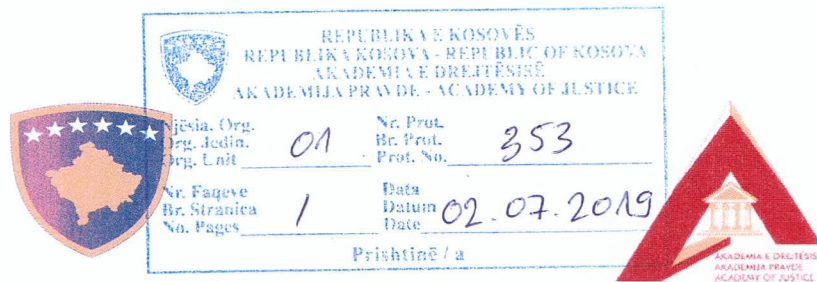

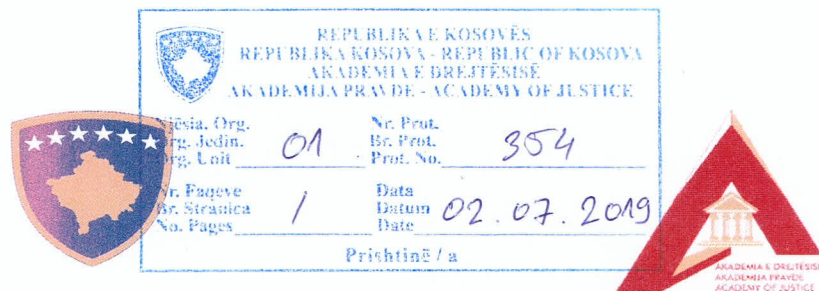

Managing Board of the Academy of Justice pursuant to Article 10 paragraph 1, subparagraph 1.9, and Article 11 paragraph 4 of the Law No. 05/L-095 on the Academy of Justice, in its seventeenth meeting of the first constituency held in June 21 2019, issues the following:

D E C I S I O N

1. Candidates that have applied for mentors at the Academy of Justice, who have submitted and completed the documents within the deadline in the first and in the second advertisement, are considered that they have met the criteria for provisional trainers at the AJ.
2. Candidates that have applied with incomplete documentation but within the deadline, and who have completed their documents after the deadline are considered as they have submitted the documents on time and have met the criteria for provisional trainers at the AJ.
3. Candidates who only miss the participant's evaluation, proof of working experience or other technical document, to be given the possibility that within the timeline of 7 days to submit these documents.
