Pursuant to Article 10 (paragraph 1, sub-paragraph 1.4) and Article 25 (paragraph 3) of Law no. 05 / L-095 on the Academy of Justice, Article 6 (paragraph 1, sub-paragraph 1.4) of Regulation No. 02/2017 on the Work of the Managing Board of the Academy of Justice, Article 14 of Regulation No. 02/2019 on Trainers and Mentors of the Academy of Justice, in the meeting held on 23.06.2021, issues the following:

DECISION

- I. Approval of the Kosovo Judicial Council proposal of Mr. Hajrullah Aruqi, mentor in the civil field judge in the Basic Court Mitrovica - Skenderaj branch, of the judge with initial mandate Arnis Dumani in the Basic Court Mitrovica - Skenderaj branch.
