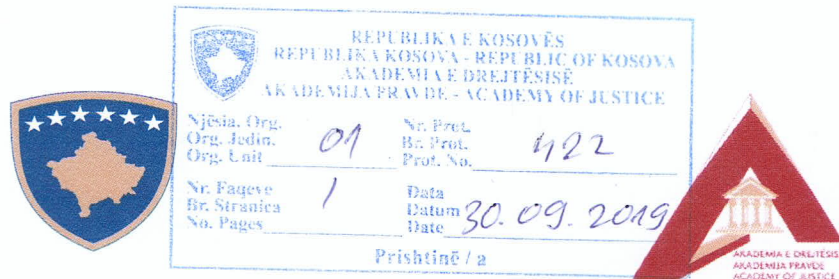

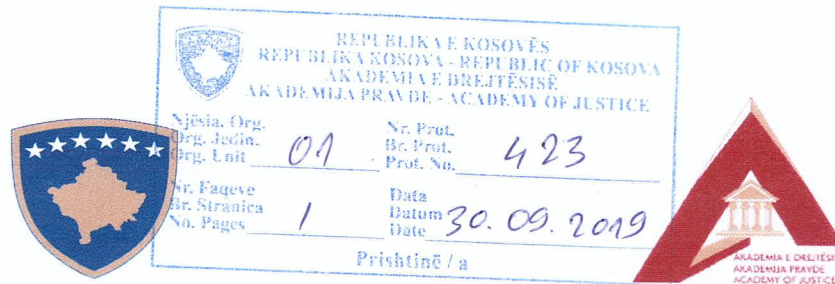

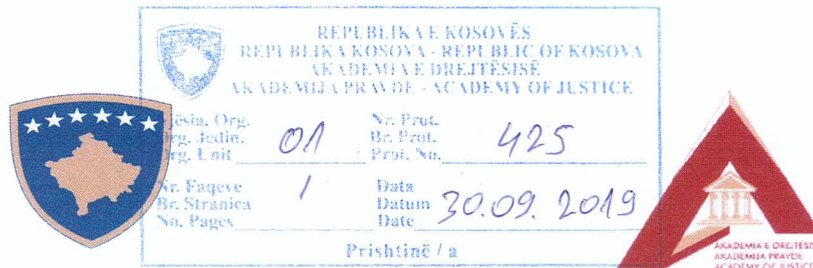

D E C I S I O N

1. Candidates who have applied to be recruited as trainees in the Academy of Justice, and submitted and completed the required documentation in accordance with the rules and criteria of the competition, shall be considered to have met the requirements for being temporary trainers and at the Academy of Justice.

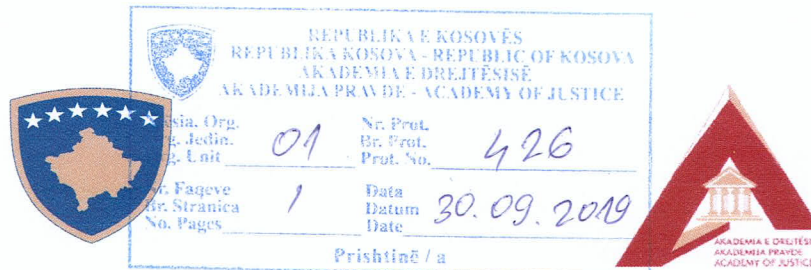

Managing Board of the Academy of Justice based on Article 10 paragraph 1 sub-paragraph 1.9, and Article 11 paragraph 4 of the Law No. 05/L-095 on the Academy of Justice, in its nineteenth meeting of the first constituency held on September 26th 2019, issues the following:

D E C I S I O N

1. That candidates that have applied for trainers at the Academy of Justice, according to the public announcements dated March 27th 2018, and December 24th 2018, that have not submitted the entire documents required in the Regulation and in the public announcement, even after the extended deadline of 7 days rendered by the Managing Board of the Academy of Justice shall be considered as they have withdrawn from this process.
2. Candidates that lack the participant's evaluation because the institution where they provided the training service did not have the evaluation mechanism in place, to be considered as they have the complete documents. This is valid for candidates that come from the community of lecturers and faculty professors, and for candidates that have attended training of trainers but were not engaged previously as trainers.

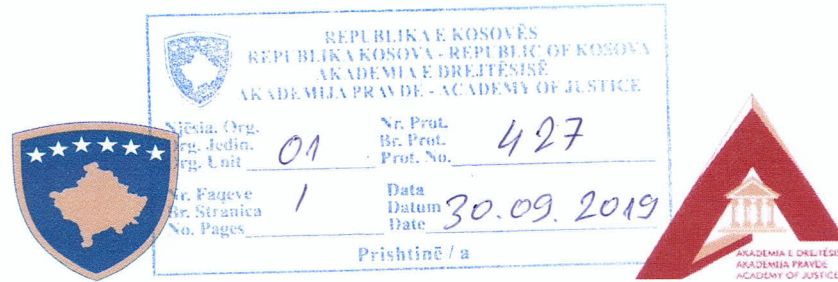

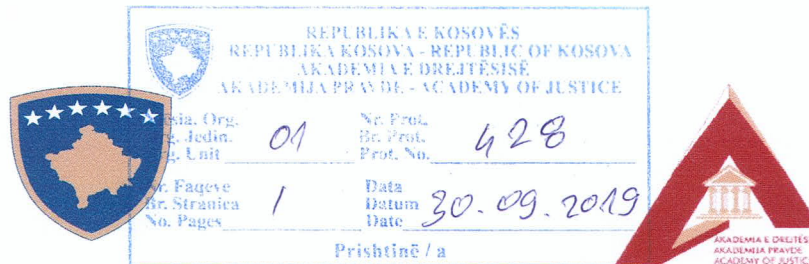

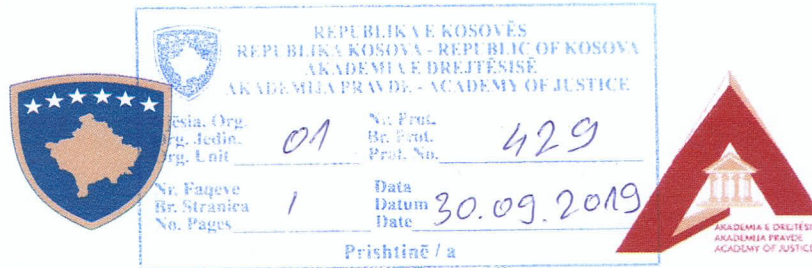
