DECISION

- I. Approving the AJ Executive Director's recommendation for establishing a coordination mechanism that will serve to promotion and coordination of activities deriving from the Action Plan for Implementing the Rule of Law Strategy 2021-2026, which relate to the Academy of Justice, Kosovo Judicial Council and the Kosovo Prosecutorial Council.
- II. Pursuant to Article 10 paragraph 2, and Article 11 paragraph 4 of the Law No. 05/L-095 on the Academy of Justice, Article 12 of the Regulation No. 02/2017 on the work of the Managing Board of the Academy of Justice, in its meeting conducted on February 28 2022, issues the following:

DECISION

- I. Establishing a special committee for evaluating the research papers of the initial training for the newly appointed judges – 8th generation.
- II. The Special committee as set forth in Article I of this decision constitutes of trainers of the initial training program for the newly appointed judges - 8th generation, who cover the respective areas of law selected by the newly appointed judges for the research papers.
- III. Compensation of the special committee members, respectively the trainers, for evaluation of the research papers as stipulated in item I and II of this decision will be in amount of **150** (one hundred and fifty) EUR gross, equivalent to the compensation of temporary trainers for one day of training.
- IV. Decision enters into force on the day of its approval.
