The Managing Board of the Academy of Justice pursuant to Article 10, point 1.9, of Law no. 05 / L-095 on the Academy of Justice, Article 6, point 1.9 of Regulation No. 02/2017 on the work of the Managing Board of the Academy of Justice in the meeting held on 29.10.2021, regarding the Memorandum of Understanding and the Protocol for the training of mandatory and additional training of the state prosecutors, issued the following:

DECISION

- I. The Proposal for signing in principle the Memorandum of Understanding for mandatory training and additional training of prosecutors between the Academy of Justice and the Kosovo Prosecutorial Council is approved unanimously.
- II. On the issue of the "JOINT PROTOCOL OF THE KOSOVO PROSECUTORIAL COUNCIL AND THE ACADEMY OF JUSTICE FOR MANDATORY TRAININGS AND ADDITIONAL TRAININGS FOR THE PROSECUTORS WITH THE LOW PERFORMANCVE" It is decided that after the finalization of the draft in the Kosovo Prosecutorial Council (KPC), its signing and implementation by the AJ and KPC will be done in a regular procedure.
- III. At the same time, MB of AJ authorizes the additional cost of financial expenses for the development of these training modules (mandatory training) according to the KPC decisions (which will be specified after the financial calculation).

Pursuant to Article 10 (paragraph 1, sub-paragraph 1.4) and Article 25 (paragraph 3) of Law no. 05 / L-095 on the Academy of Justice, Article 6 (paragraph 1, sub-paragraph 1.4) of Regulation No. 02/2017 on the Work of the Managing Board of the Academy of Justice, Article 14 of Regulation No. 02/2019 on Trainers and Mentors of the Academy of Justice, in the meeting held on 29.10.2021, issued the following:

DECISION

- I. Approval of the Kosovo Judicial Council proposal for mentor in the criminal field, of Mrs. Anita Krasniqi-Prenaj, Judge at the Basic Court in Prishtina, and of the judge with the initial mandate Mrs. Rrezarta Lleshaj in the Basic Court in Prishtina.
- II. The mandate of the appointed mentor is developed in accordance with the legislation in force and ends with the completion of the Initial Training for newly appointed judges, the provisions of the Law no. 05 / L-095 on the Academy of Justice and the Regulation No. 02/2019 on Trainers and Mentors of the Academy of Justice.
- III. The mentor is committed to implement the practical training program for a period of three (3) months, starting from December 2021.
- IV. The decision enters into force upon its approval by the Managing Board of the Academy of Justice.

Reasoning

The Academy of Justice, on 13.10.2021, has received a request with a proposal from the Kosovo Judicial Council for the approval of the mentor in the criminal field of Mrs. Anita Krasniqi-Prenaj, Judge at the Basic Court in Prishtina and of the judge with the initial mandate Mrs. Rrezarta Lleshaj in the Basic Court in Prishtina.

On October 7, 2021, the Kosovo Judicial Council took a decision on the proposal of Mrs. Anita Krasniqi-Prenaj, Judge at the Basic Court in Prishtina, for mentor in the criminal field.
