Pursuant to Article 10 (paragraph 1, sub-paragraph 1.1) and Article 11 (paragraph 4) of the Law No. 05/L-095 on the Academy of Justice, held on 25.07.2023, issues the following:

DECISION

- I. Article 4 of the Regulation No. 01/2021 on Amendment and Supplement of the Regulation no. 03/2017 on the Initial Training, is interpreted as below:
 - I.I. Evaluation of the judges and state prosecutors is made according to the following scales:
 - a. Insufficient level is considered from 0 – 60 points;
 - b. Sufficient level is considered over 60 - 80 points;
 - c. Good level is considered over 80 - 90 points;
 - d. Very good level is considered over 90 – 100 points.
 - II. Results for all the judges and state prosecutors who are in the testing stage will be evaluated according to interpretation in point I of this decision.
 - III. The Academy of Justice is obliged that based on interpretation as in Point I of this Decision, to correct the final list of the results from the final test and change the final results for the newly appointed judges of generation IX.
 - IV. The Academy of Justice is obliged that based on interpretation as in Point I of this Decision, to correct the final list of the results from the final test and change the final results for the newly appointed state prosecutors of generation IX.
- V. Decision enters into force on the day of its approval.
