Managing Board of the Academy of Justice,

Pursuant to Article 10 (paragraph 1, sub-paragraph 1.4) and Article 25 (paragraph 3) of Law No. 05/L-095 on the Academy of Justice, Article 6 (paragraph 1, sub-paragraph 1.4) of Regulation No. 02/2017 on the Work of the Managing Board of the Academy of Justice, Article 14 of Regulation No. 02/2019 for Trainers and Mentors of the Academy of Justice, based on the electronic communication via e-mail dated 30.01.2023, issued the following:

DECISION

- X. The mentor undertakes to implement the practical training program for a period of three (3) months.
- XI. The decision entered into force upon its approval.

Reasoning

The Academy of Justice, on January 25, 2023, has received a request no. 01/66 from the Kosovo Judicial Council with a proposal for approval of mentors for judges with an initial mandate, who will exercise their function in the Commercial Court and basic courts of the Republic of Kosovo, in the practical part.

The Managing Board, in the meeting held on February 16, 2023, after considering the request of the KJC, decided regarding the same as in the enacting clause of this decision.
