Managing Board of the Academy of Justice,

Pursuant to Article 10 (paragraph 1, sub-paragraph 1.4) and Article 25 (paragraph 3) of the Law No. 05/L-095 on the Academy of Justice, Article 6 (paragraph 1, sub-paragraph 1.4) of the Regulation No. 02/2017 on the Work of the Managing Board of the Academy of Justice, Article 14 of the Regulation No 02/ 2019 on Trainers and Mentors of the Academy of Justice, held on 30. 12. 2021 issues the following:

DECISION

- I. Approving proposal of the Kosovo Judicial Council for mentors of the criminal law area, for judges with the initial mandate in Basic Court in Prizren, as follows:
 1. Fatmir Krasniqi, judge in the Basic Court in Prizren
 2. Gani Kastrati, judge in the Basic Court in Prizren, and
 3. Sadije Selmani, judge in the Basic Court in Prizren
- II. Mandate of the appointed mentors concludes with completion of the Initial Training Program for the newly appointed judges and in compliance with provisions of the Law No. 05/L-095 on the Academy of Justice and Regulation no. 02/2019 on Trainers and Mentors of the Academy of Justice.
- III. Mentors are engaged to implement the practical training for the two months period.
- IV. Decision enters into force on the day of its approval.

Reasoning

Academy of Justice, on December 16 2021 received a request from the Kosovo Judicial Council for with proposal to approve the mentors of the criminal law area for judges with the initial mandate in the Basic Court in Prizren, for judges Fidan Hoxha, Arjeta Gashi and Taulant Rexhbeqaj.

On December 8 2021, Kosovo Judicial Council issued a decision for proposing Mr. Fatmir Krasniqi – judge in the Basic Court in Prizren, and Mrs. Sadije Selmani – judge in the Basic Court in Prizren as mentors of the criminal law field.

The Managing Board, in its meeting held on December 30 2021, after reviewing the KJC request decided as in the provisions of this decision.
