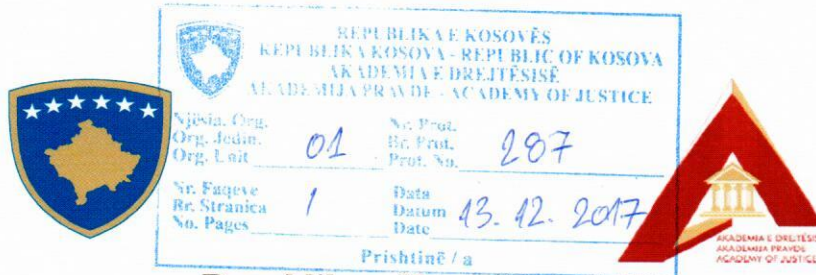
DECISION
