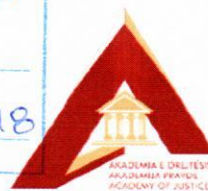

Managing Board of the Academy of Justice pursuant to Article 10 paragraph 1, sub-paragraph 1.4, Article 11 paragraph 4, and Article 25 paragraph 3 of the Law No. 05/L-095 on the Academy of Justice, and based on Article 14 of the Regulation No.06/2017 on Trainers and Mentors of the Academy of Justice, as well as based on Article 2 of the Regulation No.08/2017 on Amendment and Supplement to Regulation No.06/2017 on Trainers and Mentors of the Academy of Justice, as well as in compliance with the Decision of the Kosovo Judicial Council KJC No.342/2017, dated December 7th 2017, in its eighth meeting of the first constituency that took place on January 17th 2018 issues the following:

DECISION

1. Approving the proposal of the Kosovo Judicial Council for Mentors that will be engaged to mentor the newly appointed judges in the initial training, like stipulated below:

2. Mandate of the appointed mentors ends upon completion of the initial training by the newly appointed judges who undertake the initial training program. If during the initial training duration the judges change their function as judge, or moves from the basic instance to other instances of the court, or moves from the general department to another one, then the assignment shall be done in conformity with the respective Regulation.
3. Mentors are engaged to implement the practical training program on the criminal law area for the remaining period of the first six-month period, and another six months of the training in the civil law area.
4. Decision enters into force on the day of its signature.

Reasoning

Managing Board of the Academy of Justice, based on the proposal of the Kosovo Judicial Council made through its Decision KJC No.342/2017, dated December 7th 2017, reviewed and approved the list of names proposed by the Kosovo Judicial Council, with some changes that were proposed by representatives of the KJC to the Managing Board of the AJ.

Managing Board on 12.09.2017 issued Decision No.01/220/2017 approving mentors proposed by the Kosovo Judicial Council with its Decision KJC No.250/2017 dated 09.08.2017, rejecting some of the proposals because it found that they are in contradiction with Article 14 paragraph 1, sub-paragraph 1.1 of the Regulation No.06/2017 on Trainers and Mentors of the Academy of Justice, which stipulate “...be judges and prosecutors with permanent term in the general department of the basic instance”.

Because of the large number of judges in the initial training and the small number of judges in the General department, upon proposal of the Kosovo Judicial Council, the Academy of Justice's Managing Board with a Decision No.01/284/2017 on 01.12.2017 approved the Regulation No. 08/2017 on Amending and Supplementing the Regulation No.06/2017 on Trainers and Mentors of the Academy of Justice, which provides that possibility that mentors are assigned not only from the general departments of basic courts, but also those judges that work in other departments when there is lack of judges in the general department can be engaged as mentors.

Managing Board of the Academy of Justice did not approve entirely the proposals of the Kosovo Judicial Council as in its decision KJC No.342/2017 dated December 7 2017, since for the Basic Court of Prizren, the number of proposed mentors was larger than the participating judges in the initial training. In this case, the Managing Board approved two (2) mentors out of four (4), as per the proposal of the KJC representatives present in the AJ Managing Board meeting.

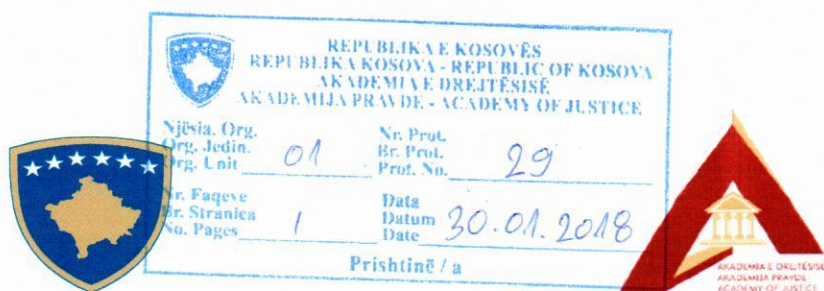

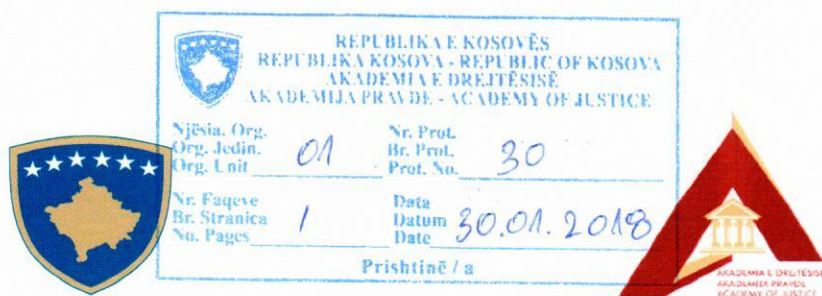
1. Members of the Editorial Board will be reimbursed in amount of 100 (one hundred) for editing of one article that is dedicated for publication in the “Justicia” magazine.
